

Datganiad Grant Amddifadedd Ysgol Carreg Emlyn 2016-17

Diben y Grant Amddifadedd Disgyblion yw gwella canlyniadau i ddysgwyr sy'n dod o deuluoedd incwm isel ac sy'n gymwys i gael prydau ysgol am ddim (PYD). Disgwylir i ysgolion ddefnyddio'r cyllid hwn i'r eithaf i gyflwyno strategaethau cynaliadwy fydd yn arwain yn gyflym at welliannau i ddysgwyr sy'n gymwys i dderbyn prydau ysgol am ddim.

Fel ysgol rydym am ddysgu o'r arferion gorau yng Nghymru a thu hwnt trwy:

1. gynllunio ymyriadau sy'n canolbwyntio ar wella cyrhaeddiad plant o gefndiroedd difreintiedig, ac sy'n nodi'n glir yr hyn a ddisgwylir gan yr ymyriad, gan fonitro cynnydd disgyblion yn gyson a gwerthuso effeithiolrwydd yr ymyriad.
2. integreiddio cynlluniau ar gyfer defnyddio'r GAD i'n Cynllun Datblygu Ysgol, gan selio arferion ar dystiolaeth dda a'u cynnwys fel rhan o strategaeth ysgol gyfan.
3. gydbwyso ymyriadau ysgol gyfan ac ymyriadau wedi'u targedu er mwyn sicrhau bod pob dysgwr sy'n gymwys i gael prydau ysgol am ddim yn cael budd fel unigolyn a bod yr ysgol gyfan yn meithrin ei gallu i helpu pob dysgwr i gyflawni ei botensial llawn.

Yn 2016-17 rhoddwyd i Ysgol Carreg Emlyn ddyraniad Grant Amddifadedd disgyblion o £4350

Yn Ysgol Carreg Emlyn mae gennym gynllun cynhwysfawr, sydd wedi'i gytuno a'i fonitro gan Awdurdod Lleol Sir Ddinbych a GwE, i hyrwyddo cynnydd a chael gwared ar rwystrau i ddysgu i fyfyrwyr sy'n gymwys ar gyfer y cyllid hwn.

Rydym wedi defnyddio'r cyllid sydd ar gael i:

- Ddatblygu y defnydd o gynlluniau megis Tric a Chlic a Read Write Inc. er mwyn codi safonau llythrennedd.
- Ddefnyddio adnodd ar lein INCERTs er mwyn tracio cynnydd disgyblion a dadansoddi'r data i gynllunio gwelliant.
- Gyfranu at gostau ymweliadau disgyblion PYD.

Nid yw'n briodol i'r ysgol gyhoeddi ei chynllun manwl oherwydd y perygl y gellid adnabod unigolion.

Ysgol Carreg Emlyn's Pupil Deprivation Grant Statement

The purpose of the Pupil Deprivation Grant is to improve the educational attainment of pupils from low income families and who are entitled to free school meals (eFSM). Schools are expected to maximise the use of this funding by introducing sustainable strategies which will quickly lead to improved outcomes for pupils entitled to free school meals.

As a school, we want to learn from the best practice in Wales and beyond by:

1. planning interventions that focus on improving the attainment of pupils from deprived backgrounds, regularly monitoring pupils' progress and evaluating the impact of the intervention.
2. integrating plans for the effective use of the PDG into the School Development Plan, basing our practice on sound evidence and including them as part of a whole school strategy.
3. balancing whole school strategies with targeted interventions to ensure that all learners entitled to free school meals benefit as individuals, whilst the whole school also develops its ability to support every learner to achieve their full potential.

In 2016-17 Ysgol Carreg Emlyn were allocated a total Pupil Deprivation Grant of £4350

Ysgol Carreg Emlyn has a comprehensive plan, agreed and monitored by GwE and Denbighshire Local Authority, to promote high expectations attainment and progress and to remove barriers to learning for pupils entitled to this funding.

We have used the funding available to:

- Develop the use of schemes such as 'Read, Write, Inc.' and 'Tric a Chlic' to raise standards in literacy.
- Use INCERT's online tracking resource to monitor pupil progress and analyse the data to plan for improvement.
- Contribute towards trips for FSM pupils.

It is not appropriate for the school to publish a detailed plan as it could identify individual pupils.
